  the resort.
- Should guests leave the resort prior to their original departure date, the charge will be equal to a maximum of 3 unused nights. Should the expected arrival not materialise, the Distributor will be charged 100% of the total cost. No refund given if client arrival is delayed by more than 24 hours due to flight delays.
- Cancellations (with reference number) must be received in writing on a per booking basis.

# ROOM SPACE FACILITY/OVERBOOKINGS

- The Distributor should report all bookings on a daily basis to M.R.I. Ltd UK and may continue to sell room
  space up to 3 days prior to arrival unless a stop sale has been issued by Rex Resorts. Bookings will be
  confirmed by M.R.I. Ltd UK. Rex Resorts reserve the right to invoke a longer release over any period of the
  agreement.
- Where allocations are given, Rex Resorts reserves the right to periodically reduce allocations by the number of unsold rooms (stop-sales). On receipt of a stop-sales notice, bookings must be reported within 2 working days (excluding weekends & public holidays). Rex Resorts will not accept responsibility for any bookings reported after that time.
- Any group booking of 5 or more rooms arriving and departing on the same day must be made on a request basis only.
- In the event of outbookings, no compensation is payable if the alternative(s) offered is of a higher category
  and/or price, otherwise compensation is limited to maximum of US\$100 per booking. Rex Resorts will not
  accept responsibility resulting out of any bookings that it cannot honour in whole or in part where advice to
  the Distributor that it cannot do so is more than eight weeks prior to the arrival date of the clients.
